Where is the other 50 percent of electricity coming from?	It will come from the grid.
Are you willing to have a placard about the history of this site?	Oh yeah.
Is there a chance that RIDC will move it's headquarters to this site?	There is a small office. We are looking at bringing jobs to the community, not occupying at this time. But if there is open space
Will this building be LEED GOLD?	Yes. We are hoping for a lot more.
